## Indiana FFA District Officer Expectations

### Introduction

As a District Officer for the Indiana FFA Organization, I understand that I will voluntarily accept a commitment to volunteer service that is unique to most student organizations. In addition to serving and representing the membership of my elected district, I understand that, as an Indiana FFA District Officer, I represent the image and direction of the Indiana FFA Organization and National FFA Organization.

### Expectations

During the period in which I am an Indiana FFA District Officer and during my service in that capacity, I agree to:

1. Be in good standing with Indiana FFA, my FFA District, FFA Chapter, and school.
2. Forego the possession or use of all alcohol, tobacco, and illegal substances at all times.
3. Hold myself to and adhere to the highest standards of integrity and honesty.
4. Refrain from conduct that may be detrimental or embarrassing to my personal reputation or the reputation of the FFA.
5. Maintain proper dress and good grooming for all occasions.
6. Treat all FFA members equally by not favoring one over another.
7. Be actively and enthusiastically supportive of my district and Indiana FFA policies and programs.
8. Faithfully uphold any additional expectations set forth by my district.
9. Logistical Commitments of District Officers.
  - A. Attend all District Officer meetings as assigned by the District President and/or District Advisor.
  - B. Attend Premier Leadership Training (PLT).
  - C. Attend district assigned State Fair Workdays and Experience Days and have plenty of people to assist.
  - D. Collaborate with my District Officer team to plan and organize my District Kickoff.
  - E. Assist in the planning, organizing and preparation for District Leadership CDE's in February, March and/or April.

### Acknowledgement

I acknowledge that if the Indiana FFA Organization or District determines that I did not adhere to any of the above-described expectations the Indiana FFA Organization or District shall have the right to take such corrective action as it determines appropriate including, but not limited to, placing limitations on me in my role as an Indiana FFA District Officer or terminating my service in that capacity.
